

## HEAVEN'S DOOR BARREL TO BARREL SWEEPSTAKES

### OFFICIAL RULES

**NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES PERIOD, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT. SO READ THEM CAREFULLY BEFORE ENTERING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE RELEASED ENTITIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.**

**ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. **SWEEPSTAKES PERIOD:** Heaven's Door Barrel to Barrel Sweepstakes (the "Sweepstakes") begins at 12:00 AM US Central Time ("CT") on May 14, 2024 and ends at 11:59 PM CT on August 19, 2024 (the "Sweepstakes Period").

The computer clock of Southern Made Services, LLC (the "Administrator") is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of Heaven's Door Spirits (the "Sponsor"), which are binding and final on matters relating to this Sweepstakes.

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States (excluding Utah) and the District of Columbia who are 21 years of age or older. VOID IN ALASKA, HAWAII, UTAH, PUERTO RICO, U.S. VIRGIN ISLANDS, AND OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW. Directors, employees, officers, agents and representatives of the Sponsor, Administrator, distributors, retailers, sales representatives and each of their respective parents, affiliates, subsidiaries and web-design, advertising, marketing, fulfillment, judging and promotion agencies, and all other agencies, corporations, partnerships or other legal entities or individuals involved in the administration, development, fulfillment and execution of this Sweepstakes, and their immediate family members, as defined below, of each, and those persons living in the same households, whether or not related, are not eligible to participate in the Sweepstakes. Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, and their respective spouses. "Household members" shall mean people who share the same residence at least three (3) months a year. Employees, officers, directors, and agents of licensed alcoholic beverage manufacturers, authorized licensees, distributors, wholesale licensees and retail licensees of alcoholic beverages, as well as state or local alcohol beverage agencies and their employees, are not eligible to participate in the Sweepstakes. Winning a Prize is contingent on fulfilling all requirements in these Official Rules. All federal,

state, and local laws and regulations apply. Void where prohibited or restricted. All Entries are the property of the Sponsor.

Participants must represent and confirm they are 21 years or older and accept these Official Rules. **2) Social Media:** Create or log in to your Instagram account (“Instagram”) and watch for Sponsor’s Instagram post (exact time of post to be determined by Sponsor at a date later than the publishing of these Official Rules). Provide a comment on Sponsor’s specially-marked post(s) with hashtag #BarrelToBarrelSweeps2024 in the comment. Upon successful completion of the foregoing, a Participant will receive one (1) social media entry (“Social Media Entry”).

Entries generated by script, macro or other automated means, and Entries by any means which subvert the entry process, are void. Entries become the property of the Sponsor and will not be returned.

Data rates may apply if entering with a mobile phone or other Web-enabled device using your wireless service provider’s network. Check with your wireless service provider for details on these and any other applicable charges. Entrants are solely responsible for any such wireless charges.

**There is a limit of one (1) Entry and one (1) Social Media Entry per person per day, using only one (1) email address or social media handle.**

Entry Guidelines:

Each Participant will indemnify and hold harmless, Sponsor and Promotion Parties from any claims to the contrary. Any Participant whose work includes likenesses of third parties or contains elements not owned by the Participant (such as, but not limited to, depictions of persons,**

**buildings, trademarks or logos [other than Sponsor's]) must be able to provide legal releases for such use including Sponsor's use of such Social Media Entry, in a form satisfactory to administrator, upon request, prior to awarding of prize.**

**As determined by the Sponsor, in its sole discretion, Social Media Entries must meet the following guidelines: (a) Must comply with these Official Rules and any Terms of Service on the applicable Web Site; (b) Cannot be sexually explicit or suggestive, unnecessarily violent or derogatory of any ethnic, racial, gender, religious, political, professional or age group, profane or pornographic, or contain nudity; (c) Cannot promote alcohol, marijuana, illegal drugs, tobacco, e-cigarettes, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message; (d) Cannot be obscene or offensive, endorse any form of hate or hate group; (e) Cannot promote terrorist acts such as providing instructions on how to assemble bombs, grenades and other such weapons or provide instructional information about illegal activities; (f) Cannot defame, misrepresent or contain disparaging or slanderous remarks about Sponsor, its customers or its products, or other people, products or companies; (g) Cannot contain trademarks, logos or trade dress owned by others (except Sponsor's trademarks, logos or trade dress), or advertise or promote any brand or product of any kind (except Sponsor's products), without permission, or contain any personal identification, such as license plate numbers, personal names, email addresses or street addresses; (h) Cannot contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art, stills, or images published on or in television, movies, the Internet or other media, except such materials owned by Sponsor) without permission; (i) Cannot contain background artwork, unless it is an original work of the entrant; (j) Cannot contain materials embodying the names, likenesses, photographs, or other indicia identifying any person, living or dead, other than the entrant, without permission; (k) Cannot communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate; and (l) Cannot depict, and cannot itself, be in violation of any law.**

Use of multiple social media accounts (more than one per platform) or the manipulation of a Participant's contact information for the purpose of obtaining more than the stated number of entries is prohibited and such persons will be disqualified, and all their Entries shall be deemed invalid. For purposes of this Sweepstakes, a "day" begins at 12:00 AM CT and ends at 11:59 PM CT.

Posting on an Instagram page that is set to private will not count towards the Social Media Entry. By submitting a Social Media Entry, Participant acknowledges and agrees that he/she will clearly and conspicuously disclose his/her participation in any online post that references or is used to

obtain Social Media Entries into the Sweepstakes. Sponsor reserves the right in its sole discretion to disqualify any Participant who does not adequately disclose his or her participation in this Sweepstakes while engaging in any online social sharing interaction during the Sweepstakes Period.

Participant must have a public profile on the Instagram account used to enter in order to be contacted by Sponsor if he/she is selected as a potential winner. By entering in the Sweepstakes, Participants hereby agree that the Sponsor may collect and use their personal information submitted with their Entry for use in connection with the Sweepstakes only. At the time of entry, Participants may be given the opportunity to opt-in to receive further communications from the Sponsor. Participants are not required to opt-in and opting in will not improve your odds of winning.

**This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with the social media platforms where content may be posted or shared.**

**SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION:** The potential winner ("Winner") will be selected on or around August 14, 2024. Odds of winning a Prize depends on the number of Entries received during the Sweepstakes Period. The Winner will be randomly selected by the Administrator and will be notified via email.

The potential Winner will be required to execute and return an affidavit of eligibility, a taxable income form, W9, a liability release and, where lawful, a publicity release, all within three (3) days of date of issuance of email notification of potential win. If such documents are not returned within the specified time period, the Sweepstakes prize notification is returned as undeliverable, the Sponsor or its agent are unable to contact a potential Winner, or a potential Winner is not in complete compliance with these Official Rules, the Sweepstakes prize will be forfeited and, at the Sponsor's discretion, an alternate Winner may be selected. The Sponsor reserves the right not to award a Sweepstakes prize in the event the Sponsor is unable to identify and confirm a Winner after attempting to contact alternate Winners.

**SWEEPSTAKES PRIZE (1):** There is one (1) prize ("Prize") available to be awarded. The Winner will receive trip to the Bourbon Trail in Pleasureville, Kentucky that includes round trip coach class airfare from the major airport nearest the Winner's home and one (1) ("Guest") to Louisville International Airport; two (2) nights in one (1) Standard Room hotel double occupancy accommodation; a VIP guided tour of the Heaven's Door Distillery for Winner and Guest; a meet and greet with the master distiller of Heaven's Door Distillery; car service to and from Heaven's Door Distillery; a dinner for two (2) at Repeal Oak Fired Steakhouse; a meal at The Last Refuge,

and merchandise from Heaven's Door Distillery. **The Approximate Retail Value ("ARV") of the Prize \$3,129. Alcohol is not part of any Prize.**

**PRIZE CONDITIONS:** Prize will be awarded provided that a sufficient number of Entries are received, and the Prize are claimed in accordance with the dates and times specified above. Prizes consist only of the elements expressly set forth above; no other elements are included in the Prize and any such expenses in connection with the use of the Prize are the sole responsibility of Winner. Winner is responsible for all applicable federal, state, local sales and income taxes and any costs, expense(s), or fees whatsoever in connection with the Prize not specifically provided herein. In the event that, for reasons beyond their control and not related to the Winner, the Sponsor is unable to award any Prize as described in these Official Rules (including if the designated Prize should become unavailable for any reason), the Sponsor may substitute the Prize with another Prize of similar nature and equal or greater value at its sole discretion. Potential Winner is subject to verification by the Sponsor and the Administrator whose decisions are final and binding.
